San Jacinto Corvette Club invites you to join us for two fun-filled days of **10 NCCC High Speed autocross** timed events on **the new outstanding track at NCM Motorsports Park**. The weekend will include 5 events each day on the exciting 2 mile West Circuit. The **number of entrants** for each event **will be limited to 65**, and priority for registration will be given to entrants registering for all 10 events. There is a discounted entry fee for registration for all events, and an additional discount for early registration by August 8. **Registration for these events is limited to NCCC Members only.**

Registration check-in and tech will begin Friday in the MSP Tech garage from 5:00pm □ 9:00pm; please have your tech completed Friday evening if possible. A hospitality area for □meet & greet□will be available at MSP Friday & Saturday evenings. Registration / tech will continue Saturday morning from 7:00am -8:15am. MSP □Quiet hours□are from 6:00pm to 8:00am; **DO NOT START A RACE CAR ENGINE DURING THIS TIME!** You may request to have your car tech done at your site on the paddock after 6:00pm. No class changes for entrants will be allowed after tech unless the car breaks and is verified by tech inspector.

All persons entering MSP will be required at the gate to sign the MSP liability waiver as well as the NCCC liability waiver, and will receive an identification arm band to be worn at all times in the facility. Entrants will have access to Motorsports Park beginning Friday afternoon at 5:00pm, and your car / trailer may be left at MSP as there will be 24-hour security at the track through Sunday. Overnight camping at the track is available from MSP: \$35/weekend per Tent or camper in the paddock: \$50/weekend per RV or camper in designated parking with electric service. Public showers and restrooms are located in the **Kimberly A. Fast pavilion**, where the MSP concession will be open for food and beverages during our 1 hour lunch breaks each day. Please note that smoking is prohibited in any MSP building. Participants are permitted to bring up to 20 gallons of fuel in acceptable containers to the track. The following fuel is available at the MSP fuel station (credit card only) in 87, 93,100 octanes (unleaded), and 110 (leaded), and diesel is also available.

We have secured the Garages at MSP for the use of event participants, and they are available for rent at a discounted rate to be included with your event registration. Eighteen single-car garages (17'X 24') are available for \$45/day, and three two-car garages (17'X 48') are available for \$75/day.

Drivers meeting will be at 8:30am in the control tower meeting room; immediately followed by parade laps of the course for entrants. Events will begin after parade laps.

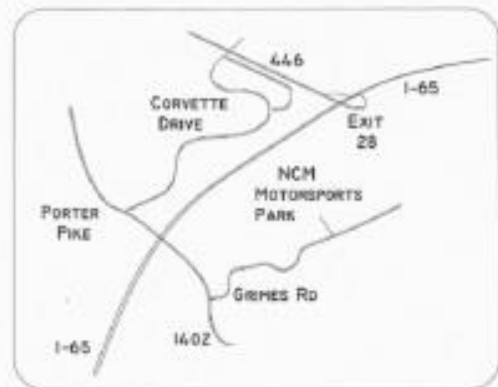

**At traffic light, Left on Corvette Drive.**  
**Proceed past National Corvette Museum.**  
**At "T" intersection, Left on Porter Pike / Hwy 1402.**  
**Proceed under I-65 overpass.**  
**Left on Grimes Road.**  
**Proceed to gate entrance to Motorsports Park.**  
**Stop at gate to sign waiver before entering MSP.**
